Subject: Required Actions upon orders for Suspension of Trading in Shares of Companies at the Stock Exchanges

WHEREAS, the Securities and Exchange Commission of Pakistan (SECP) through its letter No.SMD/SE/2(172)2008 dated August 13, 2010 (copy enclosed) has ordered suspension of trading in the shares of various listed companies which are presently in violation/ non-compliance of the Listing Regulations of the stock exchanges or laws administered by the SECP.

AND WHEREAS, the Commission in its 2nd meeting of 2010 in order to provide fair treatment to all shareholders, whether existing or prospective has approved the following policy for placing restriction on the transfer of shares in which suspension of trading in shares is ordered by the SECP or the stock exchange(s):

A suspension in the trading of the company shall also restrict all valid transactions/transfers of book entry securities on the CDC including valid withdrawal / deposit transactions, transfer of shares in physical form as well as restriction on trading in off-market. If the shares are in physical form, then on suspension of trading, the stock exchange on which the company is listed, upon suspension of trading shall obtain a fresh copy of share transfer register of the company from its respective Share Registrars/ Transfer Agents (RTA)/ the company. The stock exchange(s) shall also immediately disseminate notice of suspension of trading in the shares of any company to the relevant RTA/ the company for ensuring compliance with the above.

NOW THEREFORE, to give effect to the abovementioned policy, in order to preserve market integrity and in the best public interest, all RTAs/ listed companies shall ensure the following, for companies in which trading of shares is suspended at all the stock exchange(s) on which the company is listed (list attached as Annexure 'A'):

- (a) any new transfers of shares in physical form to be restricted immediately while any pending transfer requests already received as of August 16, 2010 to be processed and complete information of these pending transfers as on August 16, 2010 to be provided to the relevant stock exchange(s).
- (b) Further, if the shares of such suspended companies are in physical form, the stock exchange(s) shall be provided with a copy of the share transfer register as on August 16, 2010 for ensuring that no further transfer of shares (other than pending transfer requests as of August 16, 2010) takes place during the period of suspension.

Please note that similar course of actions as detailed above i.e. complete restriction on physical transfer of shares from the date of suspension of trading in a company's shares

(except the pending transfer requests already received prior to suspension date) and the provision of furnishing the share transfer register and details of pending transfers as of the suspension date, to the concerned stock exchange(s), shall also be followed in any future cases of suspension of trading in the shares of a company.
