ANNOUNCEMENT OF THE APPROVED LIST OF AUDITORS PURSUANT TO SECTION 48(1) OF THE INSURANCE ORDINANCE, 2000

Please refer to Circular Ref. 4/2014 dated January 31, 2014 whereby applications were invited from audit firms registered with the Institute of Chartered Accountants of Pakistan, to undertake audit of Insurance/Reinsurance/Takaful entities.

Pursuant to the provisions of S.48 (1) of the Insurance Ordinance 2000, as reproduced below:

"Every Insurer shall appoint an auditor who shall be approved by the commission as qualified to perform audits of insurance companies"

the commission, having reviewed the applications in the light of the Evaluation Criteria, is pleased to announce the approved list of auditors (Annexure I) along with the following instructions:

- Audit firms in category A are eligible to conduct audit of all Insurance/ Reinsurance/ Takaful
 entities.
- Audit firms in Category B are eligible to conduct audit of all Insurance/ Reinsurance/ Takaful entities having Gross Written Premium and Total Assets less than Rs. 1 billion, as per the Financial Statements in the immediate preceding year.
- Henceforth i.e. for the year ending 2014 and onwards, Insurance/Reinsurance/ Takaful entities shall appoint auditors to conduct statutory audit form the approved list issued by the Securities and Exchange Commission of Pakistan.
- The approved list shall be periodically reviewed to accommodate new firms and to categorize the firms on the basis of emerging evidences.

The above instructions shall supersede all earlier directives/circulars issued by the Commission on the subject.
