

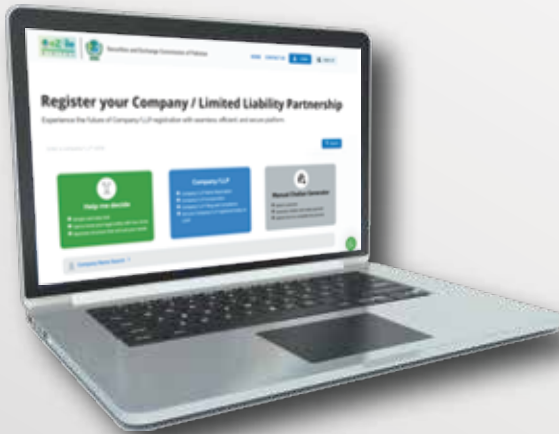

STEP 1

- Valid Passport
- Valid/Active Email Address



STEP 2

Apply for name reservation and incorporation

Information/documents required are

- ✓ A suitable **Company Name**;
- ✓ **Principle Line of Business** of the Company;
- ✓ **Registered Office Address**
- ✓ **Subscriber/shareholder**
- ✓ **Directors** (persons who will manage affairs of the company on behalf of the shareholders);
- ✓ **Company's share Capital:** Authorized & Paid-up
- ✓ **CNIC copies** of directors and subscribers
- ✓ **Application Forms (Auto Generated)**
- ✓ **Memorandum of Association** and **Article of Association** (Auto Generated)

For foreign nationals as subscribers:

- ✓ Passport, biodata, photographs
- ✓ An undertaking by the foreign director

For foreign company as subscriber

- ✓ Certificate of incorporation/business license, profile , undertaking
- ✓ BOD resolution - proposed shareholding & name of nominee
- ✓ Latest Annual Return showing the details of its directors
- ✓ Copy of the statute/charter/memorandum & articles of association

(duly certified by public officer/notary public of country of origin and signed by Pakistani diplomat posted in that country or apostilled)

Registration with Other Authorities

Third Party Information for registration with FBR, EOBI, PESSI, SESSI ETC

Step 4

Submission of application

Digital signatures by all the subscribers,
Payment of Fee and Submission

Business Structures in Pakistan

- Single Member Company (SMC)(one subscriber/member)
- Private Limited Company (min 2 subscribers/directors -Local or foreigner)
- Public Limited Company(min 3 subscribers/directors)
- Foreign Company (operate through Branch office, liaison office)
- Specialized Company (licensed entities)
- Limited liability Partnership (LLP) (registered under LLP Act, 2017)
