Data Provision Requirement for the Asset Management Companies (AMCs)

The Securities and Exchange Commission of Pakistan (the Commission) in exercise of the powers conferred under Section 282D of the Companies Ordinance, 1984, hereby directs all Asset Management Companies registered under the Companies Ordinance, 1984 to provide following data to the Mutual Fund Association of Pakistan (MUFAP) within four (4) working days after the end of each calendar month:
