(I)/2010.- The following draft of certain further amendments in the Modaraba Companies and Modaraba Rules, 1981, which are proposed to be made by the Securities and Exchange Commission of Pakistan in exercise of the powers conferred by section 41 of the Modaraba Companies and Modaraba (Floatation and Control) Ordinance, 1980(XXXI of 1980), read with clause (b) of section 43 of the Securities and Exchange Commission of Pakistan Act, 1997 (XLII of 1997), with the approval of the Federal Government, is hereby published, for information of all persons likely to be affected thereby and notice is hereby given that the draft will be taken into consideration after thirty days of its publication in the official Gazette.

Any objection or suggestion which may be received from any person in respect of the draft, before the expiry of the aforesaid period shall be taken into consideration by the Federal Government.
