#### **ORDER**

## Under S.R.O. 245 (I)/2019 read with Section 40A of the Securities and Exchange Commission of Pakistan Act, 1997

This Order shall dispose of the proceedings initiated by the Securities and Exchange Commission of Pakistan (the "Commission") against M/s. East West Insurance Company Limited (the "Company"), its Chief Executive and Directors for alleged contravention of S.R.O. 245 (I)/2019 (the "directive"). The Company and its Directors shall be collectively referred to as the "Respondents" hereinafter.

- The Company is registered under the Insurance Ordinance, 2000 (the "Ordinance") to carry on the business of non-life insurance in Pakistan.
- As per the directive, all regulated persons are required to submit compliance report on statutory regulatory orders issued by the Ministry of Foreign Affairs on United Nations Security Council Resolutions and intimation from the National Counter Terrorism Authority/Ministry of Interior regarding updates in the list of proscribed persons under the Anti-Terrorism Act, 1997, within three days of receiving the same, through email to aml.dept@secp.gov.pk by authorized officer of the regulated person. However, the Company failed to submit the compliance report in three days, in the following instances:-

- 4. In this respect, the Commission issued reminder letter dated May 9, 2019 to the Company to comply with the above-mentioned emails within seven (07) days of the date of receipt of the letter. Moreover, reminder was also sent through email dated May 9, 2019 on the email addresses of the Company i.e. ewire@cyber.net.pk, shabbir.a.kanchwala@eastwestinsurance.com.pk and saeed.ahmed@eastwestinsurance.com.pk However, the Company failed to submit any response to the reminder letter or email dated May 9, 2019 until the date of this Show Cause Notice.
- 5. The directive dated February 22, 2019 provides that, any person to whom this directive applies and who contravenes or fails to comply with the requirements of this directive or submits a return which is false in material respect or where under a misstatement is made, shall be liable to imposition of penalty under Section 40A of the Securities and Exchange Commission of Pakistan Act, 1997 (the "Act"), which may extend to ten million rupees and where such contravention is a continuing one, with a further penalty which may extend to one hundred thousand rupees for every day after the first during which such contravention continues.
- 6. In view of the above, it appeared that the Company failed to comply with S.R.O.245(I)/2019 for which, the Company and its Board of Directors were liable to be penalized under Section 40A of the Act.
- 7. The directive dated February 22, 2019 state that:
  - "iii. Compliance report on statutory regulatory orders issued by the Ministry of Foreign Affairs on United Nations Security Council Resolutions and intimation from National Counter Terrorism Authority/Ministry of Interior regarding updates in list of proscribed persons under the Anti-Terrorism Act, 1997, shall be submitted within three days of receiving the same, through email to aml.dept@secp.gov.pk by authorized officer of the Regulated Person.

Any person to whom this directive applies and who contravenes or fails to comply with the requirements of this directive or submits a return which is false in material respect or where under a misstatement is made shall be liable to imposition of penalty under section 40A of the Securities and Exchange Commission of Pakistan Act, 1997 (XLII of 1997), which may extend to ten million rupees and where such contravention is a continuing one, with a further penalty which may extend to one hundred thousand rupees for every day after the first during which such contravention continues."

- 8. Accordingly, a Show Cause Notice (SCN) No. ID/Enf/EastWest/2019/802 dated May 27, 2019 was issued to the Respondents, calling upon them to show cause as to why the fine as provided under Section 40A of the Act should not be imposed on them for the aforementioned alleged contraventions of the law.
- 9. The Authorized Representative, Mr. Shabbir Ali Kanchwala submitted comments on behalf of the Respondents, vide letter dated June 12, 2019, which are reproduced below:-

"We refer to your Show Cause Notice Ref: ID/Enf/EastWest/2019/802 dated: May 27, 2019 under S.R.O. 245 (I)/2019 read with Section 40A of the Securities and Exchange Commission of Pakistan Act, 1997. On behalf of the Board of Directors and the company we wish to reply as follows:-

- 1. The Show Cause Notice has been issued to us under an impression that that we did not reply to various emails sent by the Commission. Whereas, in fact we have replied to all received emails.
- 2. Our compliance officer Mr. Muhammad Hussain, replied mostly emails to the persons from whom the emails mentioned in the show cause notice were received. This was due to the reason that the reply emails were failed to deliver at the requisite email address i.e., <u>aml.dept@secp.gov.pk.</u>
- 3. During the period from receiving the emails and their replies till receiving of subject show cause notice, we were not notified by the officers concerned, department or any other officials that we are reporting incorrectly, which gives us an impression that we had fulfilled the requirement of the law.
- 4. The reminder of the emails contains a line i.e. "if you have already replied to the above email than you may ignore this reminder". Since, we replied the emails within due date and there was no such notification from the department about inappropriate compliance, our compliance officer considered the compliances of the requirements appropriate as per law.
- 5. In para-3 of your show cause notice you have mentioned all such emails where reporting had not been done as per the requirement of S.R.O 245 (I)/2019. Our explanation for each email is as under:

In the light of the above submission it is evident that all the emails were replied by us, which can be checked from the recipients portal, thus there is no non-compliance on the part of the company under S.R.O. 245(I)/2019, hence, do not attract any penal action under section 40A of the Securities and Exchange Commission of Pakistan Act 1997. Therefore, it is requested by taking a lenient view the Show Cause Notice under reply may kindly be withdrawn and any action in consequence may be condoned without penalty.

In case you still require further explanation/clarification with regards to our reply to the subject Show Cause Notice, the management requests for the opportunity of personal hearing before the Commission."

- 10. The Commission, vide its notice No. ID/Enf/EastWest/2019/951 dated June 24, 2019, scheduled the hearing for July 11, 2019 at the Head Office of the Commission in Islamabad.
- 11. The Company opted to appear for the hearing through video link from Company Registration Office (CRO) at Karachi .The hearing of July 11, 2019 was attended by the Authorized Representatives of the Respondents namely Mr. Shabbir Ali Kanchwala, Mr. Imran Ali Dodani and Mr. Johry Lal representing the Respondents before the Commission in the instant matter.
- 12. During the hearing the Authorized Representatives reiterated the comments submitted vide email dated June 12, 2019 and maintained that the Company responded to all the emails received from the Commission. They, however, argued that some of the emails as mentioned in the SCN were not received by the Company. The Authorized Representatives were advised to furnish evidence whether the Company responded to the final reminder letter dated May 9, 2019 issued to it prior to issuance of the Show Cause Notice.
- 13. Thereafter, as directed, the Company vide letter dated July 11, 2019 provided a copy of the reply submitted to the Commission in response to the letter dated May 9, 2019. The Company also annexed the copies of emails sent to the Commission conforming compliance with the directive. Clause (iii) of the directive states that Compliance report on statutory regulatory orders issued by the Ministry of Foreign Affairs on United Nations Security Council Resolutions and intimation from National

Counter Terrorism Authority/Ministry of Interior regarding updates in list of proscribed persons under the Anti Terrorism Act, 1997, shall be submitted within three day of receiving the same, through email to aml.dept@secp.gov.pk by authorized officer of the Regulated Person.

- 14. It appears that the Company has apparently responded to the reminder letter on May 15, 2019. i.e within the time frame provided in the letter. Perusal of the record furnished by the Company during the course of proceedings, highlights that the Respondents have complied with S.R.O. 245 (I)/2019 by submitting a compliance reports of remaining emails, reporting the status as 'nil'. Hence, I am of the view that contents of the Show Cause Notice have adequately been addressed.
- 15. I have carefully examined and given due consideration to the written and verbal submissions of the Respondents, and have also referred to the provisions of the Ordinance and other legal references. I am satisfied by the explanation and therefore, I hereby close the proceedings without any adverse order against the Respondents.
- 16. This Order is issued without prejudice to any other action that the SECP may initiate against the Company and / or its management (including the CEO of the Company) in accordance with the law on matters subsequently investigated or otherwise brought to the knowledge of the SECP.
