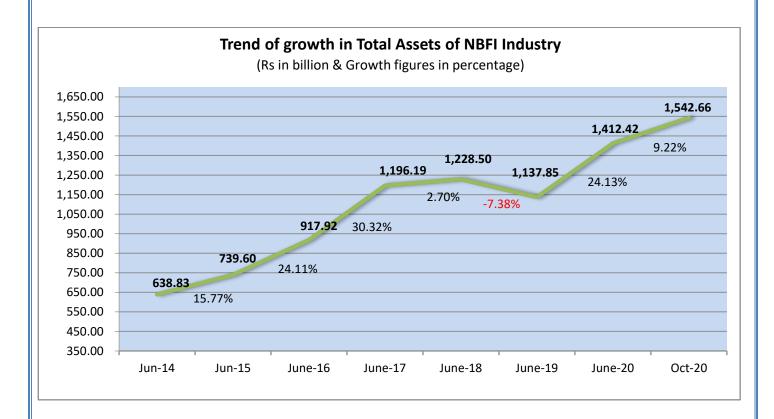

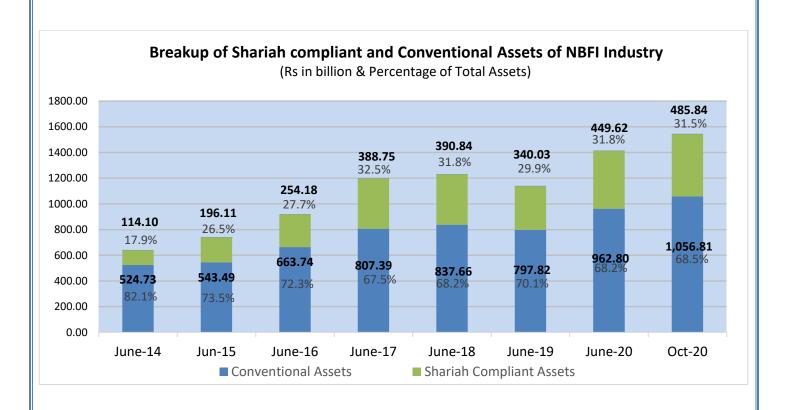

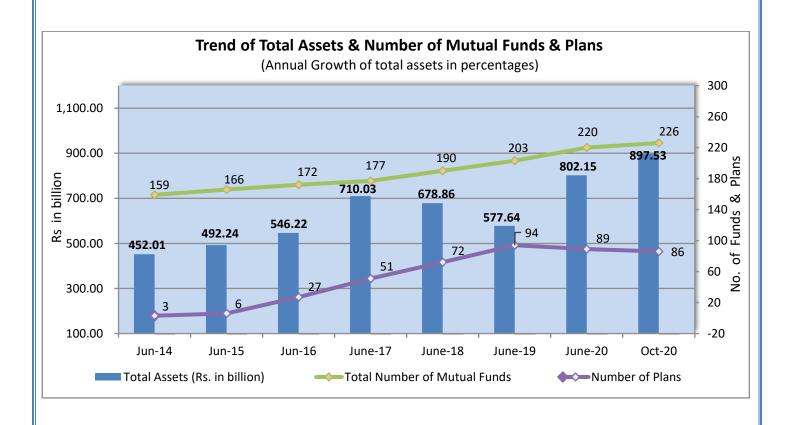

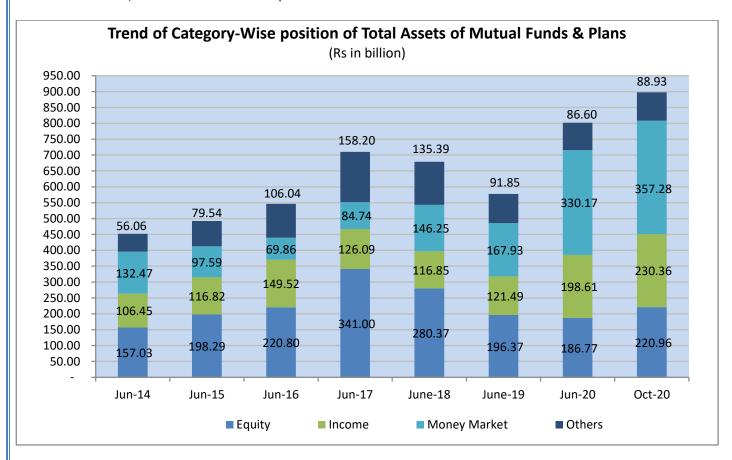


Trend of Category-Wise Position of Total Assets of Mutual Funds

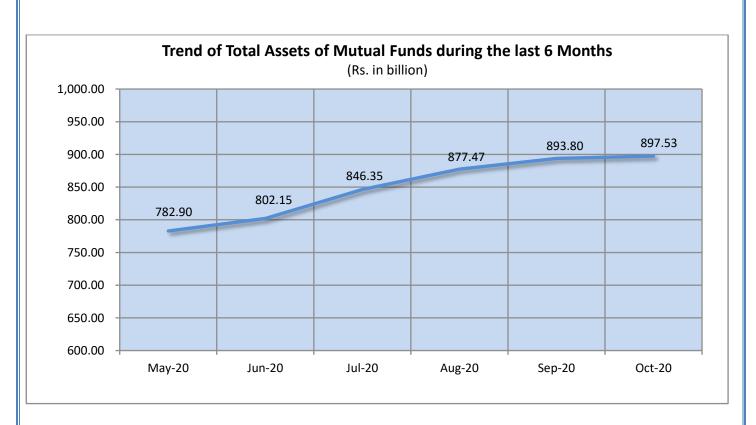

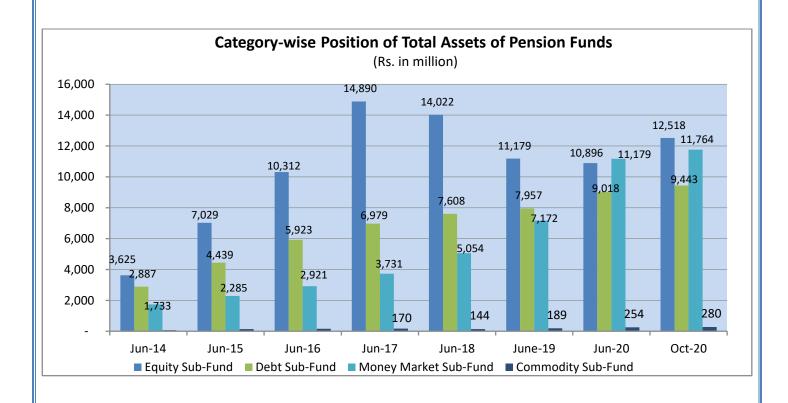

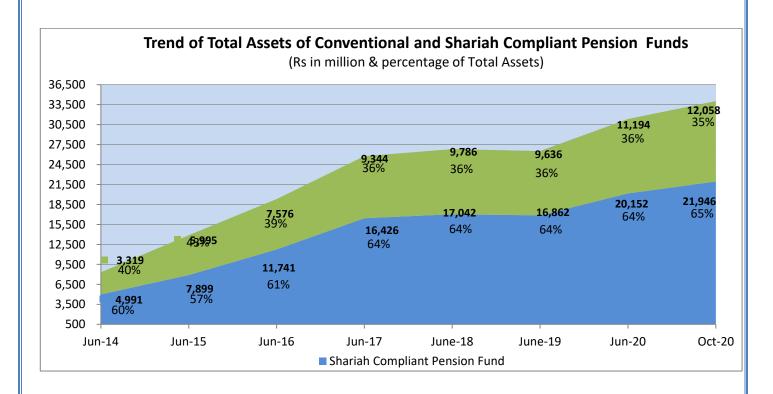

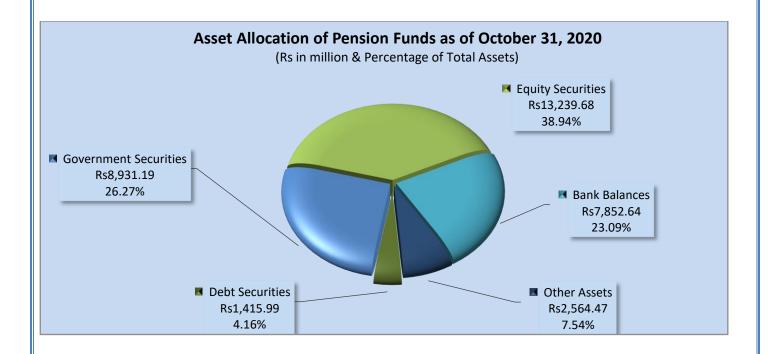

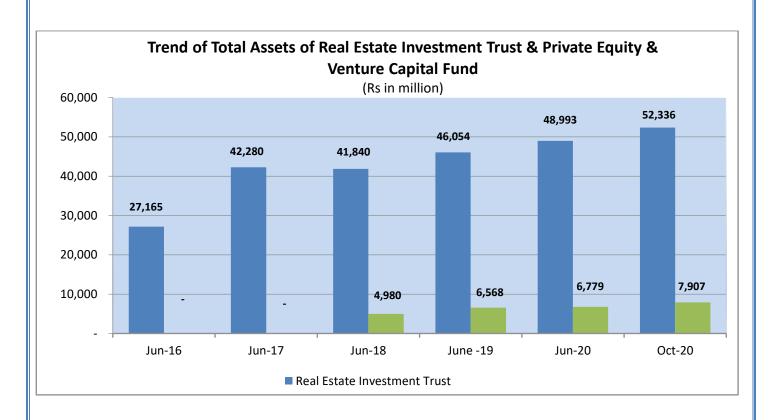
