2. Before proceeding ahead, it is necessary to advert to the following relevant provisions of the Act:

Clause VI (1) (ii) of the fourth schedule to the Act provides:

"VI. The Following shall be disclosed in the financial statements, namely:

- 1. General information about the company comprising the following:
- ii. Particulars of company's immovable fixed assets, including location and area of land."

Section 502 of the Act provides that:

- "502. Penalty where no specific penalty is provided.- If a company or any other person contravenes or fails to comply with any provision of this Act or any condition, limitation or restriction subject to which any approval, sanction, consent, confirmation, recognition, direction or exemption in relation to any matter has been accorded, given or granted, for which no punishment is provided elsewhere in this Act, the company and every officer of the company who is in default or such other person shall be liable to a penalty of level 3 on the standard scale."
- 3. In terms of the Commission's notification SRO 1545 (I)/2019 dated December 06, 2019, the powers to adjudicate cases under section 502 have been delegated to the undersigned as Executive Director (Adjudication Department-I).
- 4. From the above discussion and after careful consideration of all the facts of this case, I have observed that the Commission granted exemption to the Company vide letter dated April 15, 2019. The Company however submitted the said financial with the Commission on April 03, 2019 which was prior to the approval date of the Commission. Further the said financials were published/distributed, owing to the fact that the annual general meeting of the Company was to be held on April 25, 2019. The
