## BEFORE THE ADJUDICATING OFFICER

ORDER UNDER SECTION 130 READ WITH SECTION 479 OF THE COMPANIES ACT, 2017

### IN THE MATTER OF M/S. JAFFAR HAJJ SERVICES (PRIVATE) LIMITED

Present: Mr. Syed Sultan Muhammad (CEO)

Date of hearing: 28-Oct-2020

1. This Order shall dispose of the proceedings initiated under Section-130 of the Companies Act, 2017 ("The Act"), vide Show Cause Notice dated 29-Sep-2020 ["the Notice"].
2. The facts of the case are that the company was required to file its annual returns within thirty days from the date of the Annual General Meeting (AGM) held in the year or, when no such meeting is held or if held is not concluded, from the last day of the calendar year to which it relates in terms of provisions of section 130(3) of the Act.
3. However, the record of the company registration office revealed that the company has failed to file its annual returns for the year 2019, in violation of the above said provisions of law.
4. This constituted violation of law and rendered the company liable to penalty of level – 1 on the standard scale, provided under section 130(6)(b) read with section 479(2) of the Act. Accordingly, taking cognizance of the matter, a Show Cause Notice dated 29-Sep-2020 was served to the company through its Chief Executive as well as the directors of the company, calling upon them to Show Cause in my office on 14-Oct-2020 and subsequently adjourned on 28-Oct-2020 as to why the penalty laid down under the above mentioned section should not be imposed.
5. On the date of hearing, Chief Executive Officer (CEO) of the Company appeared before me in person. While admitting the default, he stated that delay in filing of Form-A & form-29 for the year 2019 was not intentional and occurred due to bad situation of travel agency business and pandemic of corona virus pandemic. Further, the company do not have any hajj or umrah quota from hajj ministry and not doing any business activity, in fact the management is bearing all company's expenses

from their own pockets. However, company has now filed pending form with CRO Quetta on 07/10/2020. He further apologized on behalf of the company and assured you that this thing will not happen in the future.

6. The submissions made by the CEO, who travelled all the way from Quetta to Karachi to attend the hearing, with regard to the said default are quite sustainable. The company has now made good of the default. Further, there is no evidence on the record that the subject default jeopardizes the interest of any stakeholder. I am therefore, convinced to take a lenient view. Hence, the subject default is condoned. However, the management of the company is hereby warned not to repeat the said or any other default in future and ensure the timely compliances all the statutory requirements of applicable laws, rules and Regulations.
7. A copy of this order be placed on the record of the company for future reference.
