The Corporate Rehabilitation Act, 2018 was promulgated in the year 2018 to provide for rehabilitation and reorganization of distressed corporate entities through a rehabilitation plan approved by the court. Subsequently, in exercise of powers conferred under Section 41 of the Act, the Corporate Rehabilitation Regulations, 2019 were notified by the Securities and Exchange Commission of Pakistan (the "Commission").
