Minimum qualification of promoters

Regulation 10.(2)(iii)

Qualification and experience.— A person shall possess adequate qualification and experience in order to act as promoter, director or chief executive officer of the company:

Provided that, in addition to adequate qualification, in case of single object company, the chief executive shall also possess adequate relevant experience in the field of that object; whereas, in case of multiple object company, it shall have at least one director in each field of object who possesses adequate relevant experience in that field so that all the directors collectively have adequate experience related to each object:

Provided further that, in addition to adequate qualification and experience as mentioned above, the chief executive in case of multiple object company, shall possess adequate relevant experience in the field of principal line of business of the Company.

- 2. A meeting in the office of Joint Secretary (Sports), Ministry of IPC with representatives of SECP was held on 17th February, 2022 wherein different issues regarding registration of National Sports Federations/Sports bodies were discussed in length.  - Any Sports entity/sports organization using the name of "Pakistan" will also require NOC of PSB with SECP.
- 3. SECP is requested to take further necessary action in the matter under intimation to this Ministry.

- Under the Trade Organizations Act, 2013 and Rules framed thereunder Trade Organizations are to approach the Regulator of Trade Organizations, Directorate General of Trade Organisations (DGTO), Ministry of Commerce, Government of Pakistan, Islamabad for grant of license under the relevant laws.
- Associations granted a license as a Trade Organization by DGTO must then apply and fulfill the requirements for incorporation of the proposed association under the Companies Act, 2017.
