- 2. Bids are invited for "PHOTOCOPIER SERVICES AT KARACHI" through SINGLE STAGE ONE ENVELOP METHOD

- 4. Quoted price must be in Pak rupees inclusive of all government applicable taxes.
- 5. The bidders should be registered with income tax department or ( NTN ) and the Registration number must be mentioned in the quotation and a copy of Registration Certification ( NTN ) should be provided, along with contact person's name, designation, complete postal address, and telephone & Fax number(s).
- 6. Rates of the photo copier services per page should be quoted in accordance with using imported A-4 size white paper (80 grams). Monthly photocopies will ranges between 60,000 to 70,000 numbers (approx.).
- 7. The successful bidder shall be providing at least two digital photocopier machines and one heavy duty (monochrome) network laser printer at SECP Office at Karachi.
- 8. Bidder shall quote (Lump sum) cost per copy, which includes A-4 size imported paper and shall be responsible for providing toner and all consumable accessories along with the maintenance of all machines at site, when it is required.
- 9. The successful bidder shall be responsible for providing a machine operator deputed at SECP's Karachi office from 9:00am to 6:00pm (Monday to Friday).
- 10. Rates of the photocopier services shall remain valid throughout the contract/agreement period and contract/agreement may be extended for another one year or any period with mutual consent of the Commission and the successful bidder.
- 11. Bid validity will not be less than 120 days from the bidding/bid opening date.
- 12. Commission shall be responsible for the provision of furniture & Fixture, electricity and space for Photocopier Machine(s).
- 13. Tender should be accompanied with earnest money (refundable) for an amount equal to 5 % of the total quoted price (Inclusive of applicable Taxes) in shape of

either pay order or demand draft in favor of Securities and Exchange Commission of Pakistan.

- 19. If the bid is withdrawn before the expiry of its validity or the supply/services are not made/provided within due date, the earnest money will be forfeited in favor of the SECP, Islamabad.
- 20. It is of utmost importance that bids should be submitted very carefully and the instructions set forth above, scrupulously complied with, failing which the offer will be ignored.
- 21. The proof of company's existence as a legal entity and an affidavit that the company is not blacklisted by any organization must be presented with the bid.
- 22. Discounts (if any) offered by the bidder shall be part of the bid
- 23. Detail of applicable taxes and whether included or not in the quoted price and breakup of quoted price shall be clearly mentioned.
- 24. In case applicable taxes have neither been included in the quoted price nor mentioned whether quoted amount is inclusive or exclusive of such taxes, then quoted amount will be considered inclusive of all taxes and selected service provider will have to provide the required services, if selected and declared as best evaluated bidder.
- 25. The bids received after the due date and time will not be entertained. SECP reserves the right to reject and cancel all received bids at any time of the bidding process.
