TERMS AND CONDITIONS FOR AIR CONDITIONER MAINTENANCE SERVICES

The Commission intends to acquire services for the subject matter; the quantity of the ACs is 75 approx. Nos. of different tonnage. The services will be required under following terms & conditions:

- 1. **Scope Of Work:** includes but not limited to, Periodic maintenance (gas charging, AC service etc), corrective maintenance, bi-weekly/weekly visits, upkeep and maintenance of running condition for ACs, earliest response time in case of emergency, air filter cleaning, washing of evaporator and condenser, in/out door unit servicing and complete test (electrical & Gas system checking for current drawn, oil leaks and grill temperature). Replacement of parts will be on as per actual basis and on market competitive rates.
- 2. **Price**: must be inclusive of all taxes applicable by Govt. of Pakistan.
- 3. **Rates:** Complete in all respect i.e. gas charging, general maintenance, electrical work (if required) on per UNIT basis.
