Scope of Work for Repair and over hauling of DG-27KVA

- 1. Repair faulty parts (with Guaranty) and may replace damage parts of the said generator engine.
- 2. Fix any mechanical problem at DG set.
- 3. Over hauling work
- 4. Service and tuning of Engine
- 5. Please note that above RFQ can vary as per Commission's requirement arises time to time before PO.
- 6. Interested firms/dealers must visit at site; inspect the faulty DG-27kva set at there before submitting their bids.
- 7. Bidders not visiting the site for understanding the work before bid submission shall be rejected.
- 8. No mobilization advance will be paid without any mutual agreement.
- 9. Generator would be fixed in all respect. It will run and tested prior issuing certificate of completion report.
- 10. 5% of the total cost will be withheld as retention money.
- 11. There will be six (06) month maintenance period after the completion of work. The contractor/dealer will have to replace the parts free of cost and fix the problem, if any, during that maintenance period.
- 12. Retention money will be released after successful completion of maintenance period.
