- 1 Use the expert software to produce varying kinds of comic illustrations including shaded colored illustrations with fine detail and specialized matte paintings;
- 2 Create characters that match with the storyline; unique and appealing to telling the story about the brand;
- 3 Sketch and vectorising in adding life to comic illustration using colors and special effects;
- 4 Use varied strokes in comic illustrations. With a perfect blend of thick, thin, dark and light strokes, to create the perfect representation of message;
- 5 Create artistic curves and lines and can proficiently create illustrations with inside out shapes and overlapping shapes.
- 6 The creative writing associated with the illustration will be considered as part of illustration.
- 7 The vendor has to provide high definition source files for the illustrations developed.
- 8 The created illustration should be the original work of the developer in accordance with the requirements/storyline provided by the SECP.
