

March 30, 2001 SEC issues Listed Companies (Prohibition of Insider Trading) Guidelines

The Securities and Exchange Commission of Pakistan (SEC) has issued the Listed Companies (Prohibition of Insider Trading) Guidelines. The purpose of formulating these guidelines is to curb insider trading to ensure transparency at the Exchanges, with a view to restore investor confidence in the stock market.
