Subject: SUPPLY OF UNIFORMS AND LIVERIES

The Commission requires quotations from the financially sound firms/Dealers/Suppliers registered with income or sales tax departments, for "Supply of Uniforms and Liveries", as per scope of work & items given below:-

Terms & Conditions

- The vendor shall provide quotation for supply of following
 - Uniform i.e. 15 numbers of Shalwar Mameez (white or as per sample) including stitching, labor with material and with SECP logo (complete in respect)
 - 10 pair of socks (black- cotton)
 - Waist coat 5 numbers (black as per sample) including stitching, labor with material (complete in all respect)
 - Shoes for 5 pairs for staff members (without lase) of best quality.
 - O Warm vest (full sleeved) 10 numbers (White color (cotton)
- ➤ GST and NTN number should be mentioned on the quotation. Quoted rates should be inclusive of all applicable taxes.
- > All offers should be valid for at least one hundred and twenty (120) calendar days.
- Quotations received by Fax or e-mail shall not be accepted. Unsealed quotations will not be attended.
- Quotations along with sample material of shalwar kameez suit (white KT: color with one side and one front pocket with SECP logo) socks, waist coat cloth and shoes sample should be provided within 3 days.
- > The Commission reserves the right to accept or reject any or all quotations; without assigning any reason.
- Supply of all 15 Nos. shalwar kameez suits, 5 waist coat, 5 pair of shoes, 10 warm vest and 10 pair of socks within 25 days after issuance of purchase order.
- Vendor shall be responsible for any alteration of Shalwar Kameez and waist coat if deemed necessary.
- Quality of uniforms shall not be compromised. In case, SECP officials observes any negligence in this regard then Administration Department of the SECP reserves the right to cancel the issued purchase order at any stage and no payment shall be made to the vendor.
