- **Bid Validity** Minimum 90 Days from quoted date.
- **Bid Submission deadline:** As per last date mentioned on SECP website.

- All components of the mobile application will be handed over by the contractor in their absolute entirety including source code to become the sole property of the SECP without any encumbrances whatsoever.
- Quotation shall comprise a single package containing separately the financial proposal and the technical proposal.
- The bidder must be aware of SECP regulatory requirements.
- The list of customers/clients should be attached in the technical proposal (specifically complaint mobile applications deployed at comparable government institutions).
- The service provider/supplier should also provide relevant information and evidence of its authorization and registration with the respective authority as required in the scope of work.
- Project to be completed within (3-4) Weeks after issuance of Work/Supply/Purchase Order/signing of contract.
- Designing, Development and Maintenance charges must be mentioned separately in the financial proposal.
- Companies/Firm's Seal/Stamp must be fixed on technical specification and financial proposal.
- The SECP reserves its right to cancel the entire purchase process without assigning any reason.
