The Securities and Exchange Commission of Pakistan (SECP), setup in pursuance of the Securities and Exchange Commission of Pakistan Act, 1997 is an apex regulatory authority mandated to regulate and supervise the Pakistani securities markets, corporate sector, insurance industry and non-banking financial sector etc.
- 4. The Securities and Exchange Commission of Pakistan invites sealed bids from well reputed and financially sound contractors/cafeteria service providers based in Pakistan registered with Income Tax and Sales Tax Departments for

- 5. **Pre-Bid Meeting:** In order to obtain full understanding of the TORs/Scope of Work, a meeting of the bidders is scheduled on December 08, 2017 at 1100 Hrs at SECP Head Office. Those who wish to attend/ participate should inform the undersigned.

- 7. Relevant details plus terms and conditions of this invitation may be obtained from the undersigned personally or by visiting the SECP website:

- 8. Bid Validity period should be 150 days.
- 9. It is of utmost importance that bids should be submitted very carefully and inline with the instructions of this bidding document, scrupulously complied with, failing which the offer will be ignored.
- 10. The language of the bid is English and alternative bids may not be considered.
- 11. Amendments or alterations/cutting etc., in the bids must be attested in full by the person who has signed the bids
- 12. The amount of the bid shall be in Pak Rupees.
- 13. All pages of bid must be signed and stamped by the bidder.

- 14. If services are not made/provided within due date, then security deposit will be forfeited in favor of the SECP, Islamabad.
- 15. Bidders must be registered with sales tax department, having national tax number (NTN) (if applicable). Interested bidder must submit proof of NTN and GST with the bid. Successful bidder should clearly indicate the NTN and GST Numbers in the invoice.
- 16. Taxes and duties will be deducted as per Government rules. Bid shall be submitted inclusive of all GoP taxes.
- 17. The prices quoted by the bidder shall not be adjustable. Changes or revisions in rates after the opening of the bids will not be entertained and may disqualify the original offer.
- 18. Prices quoted shall correspond to 100% of the requirements specified, and inclusive of all costs.
- 19. In case applicable taxes have neither been included in the quoted price nor mentioned whether quoted amount is inclusive or exclusive of such taxes, then quoted amount will be considered inclusive of all taxes and selected service provider will have to provide the required services/equipment, if selected and declared as best evaluated bidder.
- 20. Services provided must be paid in respect of all applied duties and taxes.
- 21. The rates must be quoted strictly in accordance with our documents and Annex(s). In the event of non-acceptance of offer no intimation will be given to the individual bidder.
- 22. Free of cost benefits (if any) offered by the bidder shall be part of the bid.
- 23. Discounts (if any) offered by the bidder shall be part of the bid.
- 24. The quantities/strength/requirements required may vary according to SECP requirement.
- 25. Only registered suppliers who are on Active Taxpayers List (ATL) of FBR are eligible to supply goods/services to the Commission.
- 26. If any supplier is not in ATL then his payment shall be stopped till he files his mandatory returns and appears on ATL of FBR.
- 27. Items included in Compulsory Certification Scheme of PSQCA shall be duly certified by an accredited laboratory and fulfill necessary conditions of PSQCA, as applicable.
- 28. The Commission does not pledge to accept the lowest bid and reserves the right of accepting full or part services offered and bidders should supply the same at the rates quoted by them.
- 29. SECP is not bound to accept the lowest bid and reserves the right to accept full or partial services/benefits offered and bidders should provide the same at the rates finalized between the agency and the bidder.
- 30. SECP reserves the right to cancel this invitation and reject all bids at any stage of the bidding process.
- 31. SECP shall disqualify a bidder if it finds at any time that the information submitted by the bidder concerning its qualification was false and materially inaccurate.

- 32. Bidders do not have the option of submitting their bids electronically. Telegraphic and conditional bids will not be accepted. Unsealed bids will not be entertained / received.
- 33. Sealed bids may be dropped in the tender drop box placed at Ground Floor of the NIC Building, 63 Jinnah Avenue, Islamabad.
- 34. Successful bidder will have to deposit a lump sum amount of Rs.100,000 as "Security Deposit" which will be released after 02 months of expiry of the contract.
- 35. Successful bidder would sign a contract/agreement with the Commission initially for the period of two years, extendable to any period mutually agreed on same terms and conditions i.e. rates etc.
- 36. Services of the successful bidder required (if any) for special events/meetings, rates will be decided with mutual negotiations as per the market rates. However, despite having selected bidder for providing Cafeteria Services, it will not bar the SECP from using the sources other than the selected bidder.
- 37. Both parties (SECP or service provider) can terminate the contract with the notice of one month's period without assigning any reason. The right to accept or reject any offer without assigning any reason is hereby reserved. The decision of the Commission would be final and binding on all matters relating to this invitation.
- 38. Bids received after the due date and time will not be entertained.

#### TERMS OF REFERENCE (TORs): HIRING OF CAFETERIA SERVICES

The Securities and Exchange Commission of Pakistan (SECP), setup in pursuance of the Securities and Exchange Commission of Pakistan Act, 1997 is an apex regulatory authority mandated to regulate and supervise the Pakistani securities markets, corporate sector, insurance industry and non-banking financial sector etc.

The Commission is desirous to have a professional, qualified and experienced contractor for Cafeteria Services at its Head Office located at Islamabad.

Bids are being invited or parties who represent and warrant that they have the requisite expertise and adequate skills to provide the services as required by the Commission.

Sealed bids are accordingly invited from reputable bidders registered with Income Tax and Sales Tax Departments (if applicable) for "Hiring of Cafeteria Service" for a period of two years for serving lunch to the employees.

#### **General Information**

- 1. The successful bidder will have to bring cooked food as per the agreed menu and serve the same at SECP Cafeteria from 12:30 PM to 3:00 PM
- 2. Bids are required for following two options:

**Option 1:** Food will be served separately in the Cafeteria as below:

- a. Double Meal/Buffet Lunch (25 Guaranteed Meals per day)
- b. Single meal/low-fat (Plate/s) Serving (Single Meals 55 and 35 Low-fat Meals Guaranteed per day)

**Option 2:** In case SECP decides Single meal/dish including low-fat meal will be served (115 (Single Meal 80 and 35 Low-fat Meals Guaranteed per day)

SECP reserves the right to continue either Single Meal/low-fat or Double Meal/Buffet Lunch serving for its employees. In such scenario, rates due to increase in strength of employees in either menus must be quoted. Rates should be quoted separately meal wise i.e Double Meal/Buffet Lunch, single dish etc.

- 3. The lunch of 115 employees per working day will be guaranteed as stated in above Option 2.
- 4. The payment to the contractor will be made by SECP on monthly basis after receipt of invoice along with verifiable supporting documents.

### **Working Days:**

Lunch will be served on Working Days Only i.e. Monday through Friday, apart from National Holidays/Holy Month of Ramadan.

#### **SECP Facilities for Contractor**

- i. Hall for serving lunch
- ii. Electricity
- iii. Tap Water for dish washing etc.
- iv. Any other item/service (to be mutually agreed).
- v. Supply of drinking water i.e. Nestle, Sparklets, Kinley, Aquafina etc. or any well known brand.

- vi. Dish washing & cleanliness of the kitchen shall rest with the contractor.
- vii. Managing daily verifiable record of Officers/Staff members availing lunch facility at cafeteria.
- viii. Professional Cafeteria Staff in uniforms
- ix. Keeping cafeteria hall and fixtures therein in good condition and carry out repair and maintenance (if required).
- x. Any other item/service essential for running cafeteria service with approval of SECP Management.

#### **Evaluation Criteria**

Each bid shall have both Technical and Financial proposals. Weightage of Technical and Financial proposals will be 60% and 40% respectively. Minimum threshold for qualifying in the technical proposal is 60%. Financial bids of only technically qualified bidders shall be considered for financial evaluation. The bidder obtaining highest marks combining both Technical and financial proposals will be awarded the contract.

#### **Evaluation criteria of financial proposal for Option 1 is as under:**

#### Single Meal

Financial Score = 15 x Amount quoted by the lowest bidder for Single Meal in financial bid
Amount quoted by the bidder whose financial score is to be calculated

#### **Double Meal/Buffet Lunch**

Financial Score = 15 x Amount quoted by the lowest bidder for Double Meal in financial bid Amount quoted by the bidder whose financial score is to be calculated

### **Low Fat Meal**

Financial Score = 10 x Amount quoted by the lowest bidder for Low fat meal in financial bid Amount quoted by the bidder whose financial score is to be calculated

#### Evaluation criteria of financial proposal for Option 2 is as under:

#### **Single Meal**

Financial Score = 20 x <u>Amount quoted by the lowest bidder for Single Meal in financial bid</u> Amount quoted by the bidder whose financial score is to be calculated

#### Low Fat Meal

Financial Score = 20 x Amount quoted by the lowest bidder for Low fat meal in financial bid Amount quoted by the bidder whose financial score is to be calculated

Note: SECP reserves the right to avail any one of the options for its employees. If two or more bidders obtain equal marks in aggregate, and become best evaluated bidders then the contract will be awarded to the one with lowest financial bid.
