The vehicles are offered for disposal "AS IS" "WHERE IS" and without resource. The sealed bid(s) in SEPARATE ENVELOPE FOR EACH VEHICLE accompanied with 10% earnest money must reach respective locations (as per bidding document) through courier or by hand, by 1100 Hrs, on **May 10**, **2019** and will be opened on the same day at 1130 Hrs.

Terms and Conditions for Bids and Bidders

- 1. "Invitation to Bid" Identification Number: # 01/2019
- 2. Bids are invited for "Disposal of Vehicles".
- 3. The Auctioning Agency is "The Securities and Exchange Commission of Pakistan".
- 4. Bid Validity period should be 90 days.
- 5. The amount of the bid and earnest money shall be in Pak Rupees.
- 6. In case if any Bidder(s) wishes to bid for more than one vehicle then earnest money should be submitted for/with each bid. Each Bid should be accompanied with earnest money (refundable) for an amount equal to 10% of the quoted price in shape of either pay order, demand draft valid for not less than 06 months in favor of **Securities and Exchange Commission of Pakistan.** Bids not accompanied by Earnest Money or with less amount than the prescribed Earnest Money shall not be entertained. (cross cheques are not acceptable). The bidder will quote price excluding all applicable taxes and successful bidder will pay the tax along with offer price separately.
- 7. Earnest Money of successful bidders will only be retained and for the unsuccessful will be returned.
- 8. If the bid(s) is withdrawn after opening and before the completion of auctioning process i.e. announcement of successful bidders, then Earnest Money submitted with such bid(s) will be forfeited in favor of the SECP, Islamabad.
- 9. The Commission does not pledge to accept the highest bid and reserves the right of auctioning full or part vehicles offered and bidders should buy the same at the rates quoted by them.
- 10. The right to accept or reject any offer without assigning any reason is hereby reserved. The decision of the Commission would be final and binding on all matters relating to this disposal.
- 11. Interested parties may visit to view the vehicles at the respective offices (Annex A) from **1000Hrs** to **1400 Hrs in working days.**
- 12. It is of utmost importance that bids should be submitted very carefully and the instructions set forth above, scrupulously complied with, failing which the offer will be ignored.
- 13. The language of the bid is English and alternative bids shall not be considered.
- 14. Amendments or alterations/cutting etc., in the bids must be attested in full by the person who has signed the bids.
- 15. The prices quoted by the bidder shall not be adjustable. Changes or revisions in rates after the opening of the bids will not be entertained and may disqualify the original offer.
- 16. The bids must be submitted strictly in accordance with conditions in our documents and Annex(s). In the event of non-acceptance of offer no intimation will be given to the individual bidder.
- 17. Bidders do not have the option of submitting their bids electronically. Telegraphic and conditional bids will not be accepted. Unsealed bids will not be entertained / received.
- 18. Bid shall comprise a single package containing one sealed envelope with earnest money.
- 19. Employees of SECP are barred to participate in the bidding process.

20. Each envelope shall bear the following identification marks in **bold and legible letters**:

22. The bid opening shall take place on:

- 23. A statement "Do Not Open Before 1130 Hrs on (May 10, 2019)" shall be clearly mentioned on the top of the sealed bid.
- 24. Commission reserves the right to entertain any late bid received after the due time and before opening of the bids, however, late Bids received after the due date and time may not be entertained.
- 25. Interested parties must assume full responsibility of any taxes, VAT or token taxes, as may be required by the law and change of ownership fees. The vehicle Toyota Cressida, IDG 1756, is non-custom duty paid vehicle; therefore, the successful bidder has to bear all type of applicable custom duty, taxes etc.
- 26. Successful bidder will have to deposit the balance of the quoted price in shape of either pay order or demand draft, in favor of Securities and Exchange Commission of Pakistan within seven working days of the date of firm written offer by the Commission plus *taxes as applicable under Section* 236A of Income Tax Ordinance 2001, and all other applicable taxes etc., otherwise, Commission will have the right to forfeit the earnest money and declare the second highest bidder as successful bidder. (Cross cheques will not be accepted)
- 27. On receipt of full payment from successful bidder, successful bidder will be issued a No Objection Certificate (NOC) and will be required to get the vehicle registered within 07 working days.
- 28. Successful bidder will have to get the vehicle transferred on his/her own responsibility. On submission of copy of registration papers/slip issued by Excise and Taxation Office of that respective city, vehicle will be delivered to the successful bidder.
- 29. The Commission reserves the right to accept or reject any or all offers without assigning any reason.
- 30. SECP reserves the right to cancel this invitation at any stage of the disposal process.
