Terms and Conditions for Bids and Bidders

- 3. The Securities and Exchange Commission of Pakistan (SECP), setup in pursuance of the Securities and Exchange Commission of Pakistan Act, 1997 is an apex regulatory authority mandated to regulate and supervise the Pakistani capital markets, corporate sector, insurance industry and non-banking financial sector etc.
- 4. The Securities and Exchange Commission of Pakistan invites sealed bids from financially sound Suppliers/contractor (s) registered with Federal Board of Revenue/Respective Revenue Boards for Income Tax and Sales Tax and who are on Active Taxpayers List (Income and Sales tax) of the Federal Board of Revenue/Relevant Tax Authority for:

- 5. Each bid shall comprise one single envelope containing, separately, financial proposal and technical proposal (if any).
- 6. Relevant details plus terms and conditions of the invitation may be obtained from the undersigned personally or by visiting the SECP website: https://www.secp.gov.pk/procurement/
- 7. The bid validity period shall be 150 days.
- 8. SECP reserves the right to reject all bids and cancel this invitation at any stage of the bidding process.
- 9. The amount of the bid and bid security shall be in Pak rupees.
- 10. The bids should be accompanied by bid security (refundable) for an amount equal to 2% of the total quoted price (inclusive GST, if applicable) in shape of either pay order, demand draft valid for not less than 6 months in favor of **Securities and Exchange Commission of Pakistan.**
- 11. Bids not accompanied by bid security or with less amount of bid security will not be entertained.
- 12. The bid security of successful bidder will be retained and that of other bidders will be returned after award of contract.
- 13. In case any bidder submits more than one option against this invitation then bid security shall be submitted against highest quoted option.

- 14. If the bid is withdrawn after opening of bids and before the expiry of its validity or the supply/services are not made/provided within due date, the bid security will be forfeited in favor of the SECP, Islamabad.
- 15. It is of utmost importance that bids should be submitted very carefully and the instructions set forth above, scrupulously complied with, failing which the offer will be ignored.
- 16. The language of the bid is English and alternative bids shall not be considered.
- 17. Amendments or alterations/cutting etc., in the bids must be attested in full by the person who has signed the bids.
- 18. The prices quoted shall correspond to 100% of the requirements specified. The prices quoted by the bidder shall not be adjustable. Changes or revisions in rates after the opening of the bids will not be entertained and may disqualify the original offer.
- 19. The rates must be quoted strictly in accordance with our documents and Annex(s).
- 20. Discounts (if any) offered by the bidder shall be part of the bid.
- 21. Detail of applicable taxes and whether taxes included or not in the quoted price and breakup of quoted price shall be clearly mentioned.
- 22. In case applicable taxes have neither been included in the quoted price nor mentioned whether quoted amount is inclusive or exclusive of such taxes, then quoted amount will be considered inclusive of all taxes and selected service provider will have to provide the required services/equipment, if selected and declared as lowest evaluated bidder. In case selected bidder is not willing to supply on quoted amount then bid security submitted with the bid will be forfeited in favor of the Commission.
- 23. The equipment/software/renewals supplied must be duty paid in respect of all applied duties and taxes. (if applicable).
- 24. The end user license, end user warranties and end user support services will be in the name of SECP for all equipment and software loaded on the equipment/services delivered.(if applicable).
- 25. A copy of valid authorized agency/partnership/dealership/distributorship certificate from their principals is to be submitted with the bid in case of any such claim.
- 26. Bidder must have regular place of business, telephone numbers and email address and must provide proof of their existence in the particular business.
- 27. Bidder must submit an undertaking with the bid that the bidder is not blacklisted by any organization.
- 28. Only registered suppliers who are on Active Taxpayers List (ATL) of FBR are eligible to supply goods/services to the Commission.
- 29. Tax shall be deducted/withheld as per applicable sales tax and income tax law.

- 30. If any supplier is not in ATL then his payment shall be stopped till he files his mandatory returns and appears on ATL of FBR.
- 31. Items included in Compulsory Certification Scheme of PSQCA shall be duly certified by an accredited laboratory and fulfill necessary conditions of PSQCA, as applicable.
- 32. The bids received after the due date and time will not be entertained.
- 33. SECP shall reject/disqualify any bidder if it finds at any time that the information submitted by the bidder is false and materially inaccurate.
- 34. Bidders do not have the option of submitting their bids electronically.
- 35. Telegraphic and conditional bids will not be accepted.
- 36. Unsealed bid/bid security will not be entertained / received and all such bids shall be rejected.
- 37. Liquidated Damages (LDs): as liquidated damages, a sum equivalent to 0.5 percent of the delivery price of the delayed goods for each week of delay until actual delivery, up to a maximum deduction of 10 percent of the delayed goods Purchase Order price.
- 38. The quantities required may increase/decrease according to SECP requirement.
- 39. Sealed bids may be dropped in the tender drop box placed at Ground Floor of the NIC Building, 63 Jinnah Avenue, Islamabad.
