- 3. **Pre-Bid Meeting:** In order to facilitate the potential bidders, a pre bid meeting will be arranged on **April 27, 2020 at 1100 hrs.** to give them overview of the overall requirements.
- 4. Bids shall comprise a single package containing TWO separate envelopes. Each envelope shall contain separately the financial Bid and the technical Bid. The envelopes shall be clearly marked as "FINANCIAL BID" and "TECHNICAL BID" in bold and legible letters.
- 5. The Bid Bond to be enclosed sealed and labelled as "BID BOND", and should be with the Technical bid envelop.
- 6. BID Bond should not be placed within the envelope of financial bid/proposal.
- 7. Initially, only the envelope marked "TECHNICAL BID" shall be opened publicly. The envelope marked as "FINANCIAL BID" and Bid Bond shall be retained.

- 9. The bid validity period shall be 150 days.
- 10. SECP reserves the right to reject all bids and cancel this invitation at any stage of the bidding process.

- 12. The amount of the bid and bid security shall be in Pak rupees.
- 13. The bids should be accompanied by bid security (refundable) for an amount equal to 2%

- of the total quoted price (inclusive GST, if applicable) in shape of either pay order, demand draft in favor of **Securities and Exchange Commission of Pakistan.**
- 14. Bids not accompanied by bid security or with less amount of bid security will be rejected.
- 15. The bid security of successful bidder will be retained and that of other bidders will be returned after award of contract.
- 16. In case any bidder submits more than one option against this invitation then bid security shall be submitted against highest quoted option.
- 17. If the bid is withdrawn after opening of bids and before the expiry of its validity or the supply/services are not made/provided within due date, the bid security will be forfeited in favor of the SECP, Islamabad.
- 18. It is of utmost importance that bids should be submitted very carefully and the instructions set forth above, scrupulously complied with, failing which the offer will be ignored.
- 19. In order to obtain full understanding of the TORs, interested bidders may visit site for exact measurement, specifications/requirement and understanding of actual work required.
- 20. The language of the bid is English and alternative bids shall not be considered.
- 21. Amendments or alterations/cutting etc., in the bids must be attested in full by the person who has signed the bids.
- 22. The prices quoted shall correspond to 100% of the requirements specified. The prices quoted by the bidder shall not be adjustable. Changes or revisions in rates after the opening of the bids will not be entertained and may disqualify the original offer.
- 23. The rates must be quoted strictly in accordance with our documents and Annex(s).
- 24. Discounts (if any) offered by the bidder shall be part of the bid.
- 25. Detail of applicable taxes and whether taxes included or not in the quoted price and breakup of quoted price shall be clearly mentioned.
- 26. In case applicable taxes have neither been included in the quoted price nor mentioned whether quoted amount is inclusive or exclusive of such taxes, then quoted amount will be considered inclusive of all taxes and selected supplier/contractor will have to provide the required supplies, if selected and declared as lowest evaluated bidder. In case selected bidder is not willing to supply on quoted amount then bid security submitted with the bid will be forfeited in favor of the Commission.
- 27. All items contain installation and commissioning and end user orientation is responsibility of the supplier.
- 28. Item supplied must be duty paid in respect of all applied duties and taxes. (if applicable)
- 29. The end user warranties and end user support services will be in the name of SECP for all items delivered.
- 30. A copy of valid authorized agency/partnership/dealership/distributorship certificate from their principals is to be submitted with the bid.

- 31. Bidder must have regular place of business, telephone numbers and email address. Bidders must provide proof of their existence in the particular business.
- 25. Bidder must submit following undertakings on stamp paper/letter head, failing which the bid shall be rejected:
  - a) That the documents/details/information submitted is true and liable to be rejecte d if proven false and in that case legal action is liable on that bidder.
  - b) That the bidder has never been blacklisted by any National / International organizations.
- 32. Only registered suppliers who are on Active Taxpayers List (ATL) of FBR are eligible to supply goods/services to the Commission. In case bidder is in-active on ATL (Income and Sales tax) then its bid shall be rejected.
- 33. Tax shall be deducted/withheld as per applicable sales tax and income tax law.
- 34. Price inclusive of quoted tax, quoted by the bidder shall be considered for evaluation irrespective of the tax rate. The lowest evaluated bidder shall be responsible of the quoted tax in its bid and any demand from tax authorities shall be payable by that bidder
- 35. If any supplier/service provider is not in ATL at the time of payment then his payment shall be stopped till he files his mandatory returns and appears on ATL of FBR/relevant revenue board.
- 36. Items included in Compulsory Certification Scheme of PSQCA shall be duly certified by an accredited laboratory and fulfill necessary conditions of PSQCA, as applicable.
- 37. The bids received after the due date and time will be rejected.
- 38. SECP shall disqualify any bidder if it finds at any time that the information submitted by the bidder is false and materially inaccurate.
- 39. Bidders do not have the option of submitting their bids electronically.
- 40. Telegraphic and conditional bids will not be accepted.
- 41. Unsealed bids shall be rejected.

#### 2. Core Scope of work Compliance Requirements:

The objective is to procure and install, hardware and software, HYBRID PABX EXCHANGE with desktop telephone sets, and integrate with the existing conventional PABX system on turnkey basis, to fulfil following requirements;

- to improve the production environment and to meet new and existing demands of PABX extensions.
- to improves the working environment, performance, scalability, flexibility and functionality
- The system must support SIP Trunks and PRI trunks
- The Hybrid PABX must have a uniform dialling plan so that intra site calling can happen via direct extension numbers
- The new Hybrid PABX must be interop with the existing PABX for extension dialling (required for Head Office Islamabad only).
- Default built-in audio conferencing depending on the availability of the SIP trunks.
- Out of 200 users at Islamabad, 21 will be IP users. IP card (hardware)/licencing and desktop client should be part of the proposal.
- Telephone sets qty may vary as per the SECP requirement.

### Future additional capabilities to be supported PABX required by SECP:

- Desktop soft client for receiving and making outside calls.
- System should be capable of call recording with/without additional hardware.

- Mobile soft client for receiving and making outside calls.
- The Hybrid PABX should support integration with video conferencing solutions i.e. Polycomm, Cisco based VC solutions.
- Active Directory integration, for a complete phone directory solution.
- LDAP Directory Synchronization (Active Directory)

- SIP trunks at Head Office and Lahore Office will be provided by SECP
- Complete System Administration Free of Cost training for 2 persons (1 each Location).
