- 5. The bid validity period shall **be 150 days.**
- 6. The amount of the bid and bid security shall be in Pak rupees.
- 7. The bids should be accompanied by bid security (refundable) for an amount equal to 2% of the total quoted price (inclusive GST, if applicable) in shape of either valid pay order/demand draft, in favor of Securities and Exchange Commission of Pakistan.
- 8. Bids not accompanied by bid security or with less amount of bid security will be rejected..
- 9. In case any bidder submits more than one option against this invitation then bid security shall be submitted against highest quoted option.
- 10. SECP reserves the right to cancel this invitation and reject all bids at any stage of the bidding process and before award of contract
- 11. Bid security of successful bids/bidders will alone be retained and that of the rest will be returned.
- 12. If the bid is withdrawn before the expiry of its validity or the supply/services are not made/provided within due date, the bid security will be forfeited in favor of the SECP.
- 13. In case applicable taxes have neither been included in the quoted price nor mentioned whether quoted amount is inclusive or exclusive of such taxes, then quoted amount will be considered inclusive of all taxes and selected service provider will have to provide the required services/equipment, if selected and declared as best evaluated bidder. In case selected bidder is not willing to supply on quoted amount then bid security submitted with the bid will be forfeited in favor of the Commission.
- 14. The quantities required may vary according to SECP requirement.
- 15. It is of utmost importance that bids should be submitted very carefully and the instructions set forth above, scrupulously complied with, failing which the offer will be ignored.
- 16. The language of the bid should be English and alternative bids shall not be considered.
- 17. Amendments or alterations/cutting etc., in the bids must be attested in full by the person who has signed the bids

- 18. The prices quoted by the bidder shall not be adjustable. Changes or revisions in rates after the opening of the bid will not be allowed and disqualify/reject the original offer.
- 19. Prices quoted shall correspond to 100% of the requirements specified.
- 20. Discounts (if any) offered by the bidder shall be part of the bid.

# 21. <u>Only registered suppliers who are on Active Taxpayers List (ATL) of FBR are eligible to supply</u> goods/services to the Commission. Bids of all those suppliers not found on ATL on the date of bid opening day shall be rejected.

- 22. After selection if any supplier is not available on ATL at the time of payment then his payment shall be stopped till he files his mandatory returns and appears on ATL of FBR.
- 23. Bidder must submit following undertakings (on stamp paper of Rs.100), failing which the bid shall be rejected:
  - a) Affidavit that the documents/details/information submitted is true and liable to be rejected if proven false and in that case legal action is liable on that bidder.
  - b) Affidavit that the bidder has never been blacklisted by any National/International organizations.
- 24. Items included in Compulsory Certification Scheme of PSQCA shall be duly certified by an accredited laboratory and fulfill necessary conditions of PSQCA, as applicable
- 25. Bidder must have regular place of business, telephone numbers and email address and must provide proof of their existence in the particular business, for not less than 01 year and proof of company as legal entity.
- 26. Any bidder who has ever supplied substandard items to SECP shall be considered ineligible for taking part in this tender competition.
- 27. Bid qualifying all requirement and quoting lowest cost of Air Conditioners and installation, with respect to each item will be selected.
- 28. Price inclusive of quoted tax, quoted by the bidder shall be considered for evaluation irrespective of the tax rate. The lowest evaluated bidder shall be responsible of the quoted tax in its bid and any demand from tax authorities shall be payable by that bidder.
- 29. Bidders do not have the option of submitting their bids electronically. Telegraphic and conditional bids will not be accepted. Unsealed bids will not be entertained / received.
