- 4. Only registered suppliers who are on Active Taxpayers List (ATL) of FBR are eligible to supply goods/services to the Commission. **Bids of all those bidders not found on ATL on the date of bid opening shall be rejected**.
- 5. If any supplier is not in ATL at the time of payment then his payment shall be stopped till he files his mandatory returns and appears on ATL of FBR
- 6. Tax shall be deducted/withheld as per applicable sales tax and income tax law.
- 7. SECP shall purchase/get the renewal/support subscription from bidder found in compliance of MUST requirement and lowest amongst all.
- 8. Relevant details plus terms and conditions of the invitation may be obtained from the undersigned personally or by visiting the SECP website: https://www.secp.gov.pk/procurement/
- 9. SECP reserves the right to cancel this invitation and reject all bids at any stage of the bidding process.
- 10. The bid validity period shall be 150 days.
- 11. The amount of the bid and bid security shall be in Pak rupees. The bids should be accompanied by bid security (refundable) for an amount equal to 5% of the total quoted price (inclusive GST, if applicable) in shape of either pay order, demand draft in favor of **Securities and Exchange Commission of Pakistan.** Bids not accompanied by bid security or with less amount of bid security will not be entertained.
- 12. In case any bidder submits more than one option against this invitation then bid security shall be submitted against highest quoted option.
- 13. If the bid is withdrawn before the expiry of its validity or the supply/services are not made/provided within due date, the bid security will be forfeited in favor of the SECP, Islamabad.

- 14. The language of the bid is English and alternative bids shall not be considered.
- 15. Amendments or alterations/cutting etc., in the bids must be attested in full by the person who has signed the bids.
- 16. The prices quoted shall correspond to 100% of the requirements specified. The prices quoted by the bidder shall not be adjustable. Changes or revisions in rates after the opening of the bids will not be entertained and may disqualify the original offer.
- 17. The rates must be quoted strictly in accordance with our documents and Annex(s).
- 18. Discounts (if any) offered by the bidder shall be part of the bid and for taxation purposes will be treated in accordance with the applicable laws.
- 19. Detail of applicable taxes and whether taxes included or not in the quoted price and breakup of the quoted price shall be clearly mentioned.
- 20. Price inclusive of quoted tax, quoted by the bidder shall be considered for evaluation irrespective of the tax rate. The lowest evaluated bidder shall be responsible of the quoted tax in its bid and any demand from tax authorities shall be payable by that bidder.
- 21. In case applicable taxes have neither been included in the quoted price nor mentioned whether quoted amount is inclusive or exclusive of such taxes, then quoted amount will be considered inclusive of all taxes and selected service provider will have to provide the required services/equipment, if selected and declared as best evaluated bidder. In case selected bidder is not willing to supply on quoted amount then bid security submitted with the bid will be forfeited in favor of the Commission.
- 22. Bidder must have regular place of business, telephone numbers and email address and must provide proof of their existence in the particular business. A brief profile of the bidder, along with list of major customers (corporate sector) along with their contact details is required.
- 23. Items included in Compulsory Certification Scheme of PSQCA shall be duly certified by an accredited laboratory and fulfill necessary conditions of PSQCA, as applicable.
- 24. Bidder must submit following undertakings (on stamp paper of Rs. 100/organization`s letterhead):
 - a. Affidavit that the documents/details/information submitted is true and liable to be rejected if proven false and in that case legal action is liable on that bidder.
 - b. Affidavit that the bidder has never been blacklisted by any Government / Semi Government/ any regulatory authority/Autonomous organization
 - c. Affidavit that no legal action has been taken by law enforcement agencies i.e. NAB, FIA etc. against the bidder.

Note: In case any bidder is found in the list of "Blacklisted Firms-Pakistan" or related links at https://www.ppra.org.pk/ then its bid shall be rejected

- 25. Comprehensive warranty & onsite support for mentioned years shall be given for the equipment/software/renewal at Islamabad, Karachi, and Lahore offices (if applicable).
- 26. All software based items contains installation and configuration and end user orientation

- which is responsibility of the supplier (if support is not provided by the Principal).
- 27. The equipment/software/renewal supplied must be duty paid in respect of all applied duties and taxes.
- 28. The quantities required may increase/decrease according to SECP requirement.
- 29. The end user License, end user warranties and end user support services will be in the name of SECP for all equipment and software loaded on the equipment delivered.
- 30. A copy of valid authorized agency/partnership/dealership/distributorship certificate from their principals is to be submitted with the bid in case of any such claim.
- 31. Payment shall be made after delivery, installation and commissioning of complete equipment/services/renewal. All payments shall be made after deduction of taxes and all payments shall be made through cross cheque in Pak Rupees. Taxes will be deducted at source as per Government Rules at the time of payment.
- 32. The bidders do not have the option of submitting their bids electronically. Telegraphic and conditional bids will not be accepted.
- 33. Unsealed bids will not be accepted.
- 34. Sealed bids may be dropped in the tender drop box placed at Ground Floor of the NIC Building, 63 Jinnah Avenue, Islamabad.

- 36. The bid security of successful bidder will be retained until renewal of licenses/support and returned after renewal of licenses/support. However, bid security of unsuccessful bidders will be returned after award of contract to successful bidder.
- 37. During the retention period the bid security, money can be utilized by Commission. Moreover no interest / markup will be provided on this amount by Commission to bidder at the time of refund/release of bid security.
- 38. Successful bidders shall be bound to provide the required services/renewal within the delivery period. In case of late delivery, late delivery (LD) charges equivalent to 1% (of the PO/contract Value) per week shall be imposed and deducted from the payment. However, imposed penalty shall not exceed 10% of the PO/contract value.
- 39. The bids received after the due date and time will not be entertained.
- 40. It is of utmost importance that bids should be submitted very carefully and the instructions set forth above, scrupulously complied with, failing which the offer will be ignored.
