The Securities and Exchange Commission of Pakistan ("SECP" or the "Commission") invites sealed bids only from already Pre-Qualified Firms (*Pre-Qualified for "hiring of Security Services"*, against SECP's T#14/2021-22 and PPRA's Tender No. TS475703E) based in Pakistan, registered with Federal Board of Revenue/Respective Revenue Boards for Income Tax and Sales Tax and who are on Active Taxpayers List (Income and Sales tax) of the Federal Board of Revenue/Relevant Tax Authority for:

SINGLE STAGE ONE ENVELOP

- 4. Pre-qualified firms who are on Active Taxpayers List (Income and Sales Tax) of FBR/ Relevant Tax Authority are only eligible to provide services to the Commission. Bids of all those bidders who are In-Active on ATL on the date of bid opening shall be rejected.
- 5. Relevant details plus terms and conditions of the invitation may be obtained from the undersigned personally or by visiting the SECP website: https://www.secp.gov.pk/procurement/
- 6. SECP reserves the right to cancel this invitation and reject all bids at any stage of the bidding process.
- 7. The bid validity period shall be 150 days.
- 8. The bids should be accompanied by bid security (refundable) for an amount equal to 2% of the quoted price (inclusive GST, if applicable) in shape of either pay order, demand draft in favor of Securities and Exchange Commission of Pakistan. Bids not accompanied by bid security or with less amount of bid security shall be rejected.
- 9. The amount of the bid and bid security shall be in Pak rupees.
- 10. The prices quoted shall correspond to 100% of the requirements specified. The prices quoted by the bidder shall not be adjustable. Changes or revisions in rates after the opening of the bids will not be allowed and may result in disqualification of the original offer.
- 11. The rates must be quoted strictly in accordance with our documents and Annex(s) while also ensuring compliance to minimum wages announced by the Government of Pakistan.
- 12. Discounts (if any) offered by the bidder shall be part of the bid and for taxation purposes will be treated in accordance with the applicable laws.
- 13. Detail of applicable taxes and whether taxes included or not in the quoted price and breakup of the quoted price shall be clearly mentioned.
- 14. In case applicable taxes have neither been included in the quoted price nor mentioned whether

quoted amount is inclusive or exclusive of such taxes, then quoted amount will be considered inclusive of all taxes and selected service provider will have to provide the required services/equipment, if selected and declared as best evaluated bidder.

- 15. The language of the bid should be in English and alternative bids shall not be considered.
- 16. Amendments or alterations/cutting etc., in the bids must be attested in full by the person who has signed the bids.
- 17. Bidder must submit the undertaking as per format prescribed in relevant Annexure, failing which the bid shall be rejected.
- 18. Bids from any bidder who is found or purported to be engaged or under investigation for offences related to fraud, terror financing, money laundering etc. shall be rejected without assigning any reason.
- 19. The services/equipment/software/renewals supplied must be duty paid in respect of all applied duties and taxes.
- 20. Required quantities may increase/decrease according to SECP requirement, if applicable.
- 21. After selection if any supplier is not available on ATL at the time of payment then his payment shall be stopped till he files his mandatory returns and appears on ATL of FBR.
- 22. Tax shall be deducted/withheld as per applicable sales tax and income tax law.
- 23. SECP shall hire/select the bidder found in compliance to the requirement mentioned in the bidding document and lowest in price/service charges amongst all.
- 24. Bid found in compliance of all the requirements and quoting least cost/lowest price, shall be selected being Most Advantageous bid.
- 25. In case selected bidder is unable to supply/provide services on quoted amount then bid security submitted with the bid shall be forfeited in favor of the Commission.
- 26. If the bid is withdrawn before the expiry of its validity or the supply/services are not made/provided within due date, the bid security will be forfeited in favor of the SECP, Islamabad.
- 27. The bid security of successful bidder will be retained until renewal of licenses/support and returned after renewal of licenses/support is confirmed. However, bid security of unsuccessful bidders will be returned after award of contract to successful bidder.
- 28. During the retention period the bid security no interest / markup will be paid on this amount by Commission to bidder at the time of refund/release of bid security.
- 29. In case 1st Most Advantageous bidder is unable to provide the services then the Commission reserve the right to award the contract to 2nd Most Advantageous bidder. In case 2nd lowest evaluated bidder is unable to provide the services then the Commission reserve the right to award the contract to 3rd Most Advantageous bidder.
- 30. Price inclusive of quoted tax, quoted by the bidder shall be considered for evaluation irrespective of the tax rate. The lowest evaluated bidder shall be responsible of the quoted tax in its bid and any demand from tax authorities shall be payable by that bidder.
- 31. Payment shall be made after completion of services as per the schedule in 11 above. All payments shall be made after deduction of taxes and all payments shall be made through cross cheque in Pak

Rupees. Taxes will be deducted at source as per Government Rules at the time of payment.

- 32. The bidders do not have the option of submitting their bids electronically. Telegraphic and conditional bids will not be accepted.
- 33. Unsealed bids will be rejected.
- 34. Sealed bids may be dropped in the tender drop box placed at Ground Floor of the NIC Building, 63 Jinnah Avenue, Islamabad.
- 35. In respect of the Services being rendered in Islamabad and all the provinces (except Baluchistan), sales tax will be charged on the gross amount of invoice including the services charges of the vendors plus salaries, overtime, incentives, perks and benefits, statutory payments and all payments made to or on behalf of the employees including but not limited to EOBI, ESSI, Gratuity, GLI, Medical Insurance etc.
- 36. In respect of services being rendered in the Province of Baluchistan, sales tax shall be charged only on the services charges of the vendors.
- 37. Sales tax will be withheld and deposited with the relevant authorities in accordance with the relevant laws and rules as applicable from time to time.
- 38. Income tax @ 3% shall be withheld from the gross amount of the invoice (inclusive of sales tax) which includes services charges of the vendors plus salaries, overtime, incentives, perks and benefits, statutory payments and all payments made to or on behalf of the employees.
- 39. Any bidder who has not quoted its financial proposal keeping in view the above mentioned tax treatment, his proposal shall not considered and rejected without assigning any reason.
- 40. Any change in future with respect to aforementioned tax treatment shall be dealt and applied as per law.
- 41. Bidder must submit the undertaking as per format prescribed in relevant Annexure, failing which the bid shall be rejected.
- 42. In case any bidder is found in the list of "Blacklisted Firms-Pakistan" or related links at https://www.ppra.org.pk/ then its bid shall be rejected.

- 44. Successful bidders shall be bound to provide the required services within the committed delivery period.
- 45. In case of late delivery, late delivery (LD) charges equivalent to 1% (of the PO/contract Value) per week shall be imposed and deducted from the payment. Provided that the imposed penalty shall not exceed 10% of the PO/contract value. However, no penalty shall be deducted in case delay is:
 - a. on part of the Commission; or
 - b. due to occurrence of event(s) beyond the reasonable control of the firm, which have a materially adverse effect on the ability of the Firm to perform its obligations.

In case of clause "b" above, the decision of the Commission to determine the occurrence of event(s) beyond the reasonable control of the Firm or otherwise shall be final and binding.

- 46. Bid(s) received after the due date and time i.e. bid submission, will be rejected.
- 47. It is of utmost importance that bids should be submitted very carefully and the instructions set forth above, scrupulously complied with, failing which the offer will be ignored.
