#### TERMS AND CONDITIONS FOR BIDS AND BIDDERS

- 1. "Invitation to Bids" Identification Number **T#01/IT&JI/D/03/2023**
- 2. Bids are invited for "Disposal of Surplus IT Assets and Junk Items".
- 3. The Asset Disposing Agency is "The Securities and Exchange Commission of Pakistan".
- 4. Bid/offer should be valid for 90 days.
- 5. The amount of the bid and earnest money shall be in Pak Rupees.
- 6. Each Bid should be accompanied with earnest money (refundable) for an amount equal to 10% of the quoted price in shape of either pay order, demand draft valid for not less than 06 months in favor of **Securities and Exchange Commission of Pakistan.** Bids not accompanied by Earnest Money or with less than the prescribed amount of Earnest Money shall not be entertained. (Cross cheques are not acceptable). The bidder will quote price EXCLUDING all applicable taxes and successful bidder will pay the tax along with offer price separately.
- 7. Earnest Money of successful bidders will alone be retained and that of the rest will be returned.
- 8. If the bid(s) is withdrawn after opening and before the completion of auctioning process i.e. identification of successful bidders, then Earnest Money submitted with a such bid(s) will be forfeited in favor of the SECP, Islamabad.
- 9. After the opening of the bids, earnest money of offers may be returned immediately other than 1<sup>st</sup> & 2<sup>nd</sup> highest bidder.
- 10. The Commission does not pledge to accept the highest bid and reserves the right of disposing of full or part assets offered and bidders shall buy the same at the rates quoted by them.
- 11. As surplus IT assets and junk items are available at different locations therefore successful bidder will be responsible to bear, the transportation cost (If any.)
- 12. The right to accept or reject any offer without assigning any reason is hereby reserved. The decision of the Commission shall be final and binding on all matters relating to this tender.
- 13. Interested parties may visit to view the condition of assets for disposal at Commission's head office and regional offices from 1000Hrs to 1600Hrs on any working day. (Monday Friday).
- 14. The language of the bid shall be English or Urdu and alternative bids may not be considered.

- 15. Amendments or alterations/cutting etc., in the bids shall be attested in full by the person who has signed the bids.
- 16. The offers quoted by the bidder shall not be adjustable. Changes or revisions in rates after the opening of the bids will not be entertained and shall disqualify the original offer.
- 17. It is a package deal (IT assets and other assets); therefore, rates shall be quoted strictly on a lump sum basis for both categories mentioned in Annexure A to the bid documents.
- 18. Interested parties shall assume full responsibility for any taxes as may be required by the law.
- 19. The bidder will quote a price **EXCLUDING** all applicable taxes and the successful bidder will pay the tax along with the offer price separately.
- 20. Bids shall not be submitted electronically. Telegraphic and conditional bids will also not be accepted. Further, unsealed bids/incomplete bids will not be entertained/received.
- 21. Bid shall be composed of a single envelope containing the information be on the prescribed format.

- 26. Bids received after the due date and time will not be entertained.
- 27. Successful bidder will have to deposit the balance of the quoted price in shape of either pay order or demand draft, in favor of Securities and Exchange Commission of Pakistan

within three working days of the date of firm written offer by the Commission; plus, taxes as applicable under Section 236A of Income Tax Ordinance 2001, otherwise, Commission will have the right to forfeit the earnest money and declare the next highest bidder as successful bidder. (Cross cheques will not be accepted)

- 28. On receipt of full payment from successful bidder, successful bidder will be required to transport the bought assets (on his/her own) within 07 working days from all locations mentioned, otherwise, Commission will not take any responsibility of the sold assets. Transportation charges shall be borne by the bidder.
- 29. The Commission reserves the right to accept or reject any or all offers without assigning any reason.
- 30. It is of utmost importance that bids shall be submitted very carefully and in accordance with the instructions set forth above, failing which the offer will be ignored.
